The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 07/21/2021, and investigated by Teddie Schrayner

A statement of childcare allegation, CPL-47623, was provided on 07/21/2021.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements
Section 14. Health and Safety Requirements
(l) Potentially dangerous or unsafe items shall be made inaccessible to children.

Explanation of Findings: During the facility inspection, it was observed that there was gasoline, round up, and paint that was accessible to children.

Action Required: All hazardous items were moved and placed out of reach of children while Licensor was at the facility. Please submit a corrective action plan to the Licensing Office showing how you will assure that all hazardous items will be kept out of reach of children.

Administrative hearing procedures are included in the Wyoming Department of Family Services Contested Case Hearing Rules, Chapter 2, Substitute Care and Child Care Licensing and based on the above statute. If you need a copy of the Rules, or assistance in requesting an Administrative hearing, you may contact the Department of Family Services Field Office in the county where you live.
