The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 03/26/2021, and investigated by Michelle Tucker

A statement of childcare allegation, CPL-46955, was provided on 03/26/2021.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements

Section 3. Provider, Director, and Staff Requirement

(a) Before the provider, director, their staff, household member, substitute or volunteer assume responsibility for the direct care of children, work in the facility or move into the Family Child Care Home or Family Child Care Center, the following shall be on file:

(iii) A child abuse/neglect Central Registry check which does not reveal any disqualifying information.

Explanation of Findings: It was found by licensing at an unannounced inspection on March 26, 2021 that one employee, ML, has been working in the facility with a central registry abuse and neglect background check that expired in August of 2020 and a new central registry background check was not requested.

Action Required: Immediately submit a central registry abuse and neglect screening for employee ML and submit a variance to allow ML to continue working while results are processed. Complete the Corrective Action plan form detailing how the facility will ensure that all the annual required central registry back ground checks are requested in a timely manner and kept current and on file at the facility.

If you disagree with the Department's finding of a non-compliance violation, you may request an Administrative hearing within (10) days of your receipt of this letter (W.S. 14-4-108). Administrative hearing procedures are included in the Wyoming Department of Family Services Contested Case Hearing Rules, Chapter 2, Substitute Care and Child Care Licensing and based on the above statute. If you need a copy of the Rules, or assistance in requesting an Administrative hearing, you may contact the Department of Family Services Field Office in the county where you live.
