Section 16. Outdoor Play Space.

(k) Outdoor play areas shall be free from miscellaneous debris or litter such as tree branches, soda cans, bottles, glass, or animal waste.

Explanation of Findings: Observed dog fecal matter throughout outdoor play space along with bags of trash torn open on the porch.

Action Required: Please enact a plan to ensure fecal matter is cleaned up prior to and during all operational hours of the child care.
