- (a) Child care facilities shall maintain complete and updated administrative, staff and children's records on-site. All records shall be retained for a minimum of three (3) years.
- (i) All records for children actively participating in a program shall be reviewed and updated annually.

Explanation of Findings: Upon reviewing children's records licenser observed several records that have not been updated in the last year.

Action Required: Please have all children's records updated and let the licenser know in writing when they are up to date. Fill out a Corrective Action Plan ensuring that children's records will be updated annually.
