The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 09/25/2020, and investigated by Kathy Geringer

A statement of childcare allegation, CPL-46170, was provided on 09/25/2020.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements

Section 3. Provider, Director, and Staff Requirement

(e) All staff, household members, substitutes, and volunteers shall complete a child abuse/neglect Central Registry background check once a year and a full fingerprint based national criminal history record background check every five (5) years.

Explanation of Findings: Staff A.K.'s WY C.R. expired on 9/4, the new one was not completed until 9/18. She was working in the facility during the lapse.

Action Required: Submit a Corrective Action Plan to the Licenser stating what measures will be enacted to ensure that Central Registries for all staff are kept current.
