Explanation of Findings: It was found at an unannounced visit on December 10, 2021 that one staff member of the facility was working unsupervised with children without the required out of state abuse and neglect central registry check.

Action Required: Complete a variance request form for MB by the end of the day on 12/10/2021. Submit out of state central registries for MB as soon as possible. Complete the corrective action plan detailing how the facility will ensure that out of state background checks or a variance for them is on file before allowing employee to be unsupervised.
