The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 10/15/2021, and investigated by Michelle Tucker

A statement of childcare allegation, CPL-48064, was provided on 10/15/2021.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

## 1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements

Section 3. Provider, Director, and Staff Requirement

- (a) Before the provider, director, their staff, household member, substitute or volunteer assume responsibility for the direct care of children, work in the facility or move into the Family Child Care Home or Family Child Care Center, the following shall be on file:
- (iii) A child abuse/neglect Central Registry check which does not reveal any disqualifying information.

Explanation of Findings: It was during an extra unannounced visit on October 15, 2021, that one staff member's child abuse/neglect central registry check and sex offender check had expired and was not re-run. All other staff records were in compliance at the time of the visit.

Action Required: Immediately request a variance and submit the central registry form for processing. Complete a corrective action plan detailing how the facility will ensure that central registry background checks will be submitted in a timely manner.
