The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 07/20/2021, and investigated by Kristi Bennick

A statement of childcare allegation, CPL-47608, was provided on 07/20/2021.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements  
Section 3. Provider, Director, and Staff Requirement  
(a) Before the provider, director, their staff, household member, substitute or volunteer assume responsibility for the direct care of children, work in the facility or move into the Family Child Care Home or Family Child Care Center, the following shall be on file:  
(iii) A child abuse/neglect Central Registry check which does not reveal any disqualifying information.

Explanation of Findings: A finding of non-compliance is based on observation by licenser that central registry and sex offender check is expired for Angelina Bruso. Central registry and sex offender check is not on file for Bailey Brenneman.

Action Required: Angelina and Bailey left at the time of the visit. They may return when central registry and sex offender check results are on file or program can request a variance. If variance is approved, Angelina and Bailey may be used as staff but can not be left unsupervised.

2. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements  
Section 9. Training  
(e) All staff shall have Infant/Child Cardiopulmonary Resuscitation (CPR) and First Aid (FA) training and certification shall be kept current.

Explanation of Findings: A finding of non-compliance is based on observation by licenser that first aid and CPR card is not on file for Ariana Middleton.

Action Required: Ariana must be supervised by fully qualified staff until card is on file.
