The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 07/28/2020, and investigated by Ashley Dame

A statement of childcare allegation, CPL-45815, was provided on 07/28/2020.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

Section 16. Outdoor Play Space

(i) Outdoor play equipment with a fall height of more than 24 inches shall be installed over a resilient surface covering the appropriate use zones:

(iv) Resilient surfacing shall be installed, maintained and replaced according to the manufacturer's instructions.

Explanation of Findings: Explanation of finding of non-compliance. At the 7/28/20 visit, it was observed that surfacing is needed in the use zone.
