The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 06/30/2021, and investigated by Teddie Schrayner

A statement of childcare allegation, CPL-47522, was provided on 06/30/2021.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements  
Section 10. Records

(d) Individual child's records shall be in place before a child is left in care and shall include:  
(vii) Immunization records as required by W.S. 14-4-116 and the Department of Health, Immunization Program, except for school age children who are attending public school. In programs that are operated on a drop-in basis, immunization records for children are not required, but recommended to be on file. If attendance on a drop-in basis exceeds 30 calendar days, immunization records are required;

Explanation of Findings: During the facility inspection, it was observed that Tina was missing immunization records for B.Y.

Action Required: Requested verification of immunization records for the child's record folder. Also, a corrective action plan showing that she will assure all records are current and complete for all enrolled children.
