The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 09/14/2021, and investigated by Joshua Seilaff

A statement of childcare allegation, CPL-47892, was provided on 09/14/2021.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements

Section 2. Capacity/Supervision Requirements

(b) Staff:child ratios and supervision requirements as described in this chapter shall be maintained at all times.

Explanation of Findings: It was observed that at the time of the visit on 09/14/2021 the facility has a total of 2 - 1 year old's and 7 - 2 year old's in attendance with one staff person, Jatanna. There are more than 5 two year old in attendance with one staff person, and there are more than 6 children in attendance who are under the age of 3 for a total of 9 children.

Action Required: Please submit a corrective action plan to child care licensing stating how the facility will ensure compliance with staff:child ratios at all times going forward. Future monitoring visits may occur.

Administrative hearing procedures are included in the Wyoming Department of Family Services Contested Case Hearing Rules, Chapter 2, Substitute Care and Child Care Licensing and based on the above statute. If you need a copy of the Rules, or assistance in requesting an Administrative hearing, you may contact the Department of Family Services Field Office in the county where you live.
