Explanation of Findings: A substitute staff present and caring for children at the time of the Licenser's arrival does not have current WY Central Registry, Fingerprints, Sex Offender Registry Results, or TB on file.

Action Required: Mrs. Walson returned to the child care prior to the end of the visit to restore correct ratios by qualified staff. Submit a Corrective Action Plan to the Licenser advising how this violation will be prevented in the future. Also send documentation of completed staff records.

2. Finding: Non-Compliant

Section 9. Training.

(b) Within three $(\bar{3})$ months of a person's start date and prior to assuming responsibility for unsupervised direct care of children, all staff shall receive the approved pre-service training, facility staff orientation training and Wyoming Early Learning Standards (Early Learning Guidelines and Early Learning Foundations) training (8 credits).

Explanation of Findings: A substitute staff is the only person present and providing care to children in care, the staff has not had Facility Staff Orientation, Pre-service Orientation, and Early Learning Standards, or a current CPR/FA.

Action Required: Mrs. Walson returned to the child care prior to the end of the visit to restore correct ratios by qualified staff. Submit a Corrective Action Plan to the Licenser advising how
