The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 05/10/2021, and investigated by Teddie Schroyer

A statement of childcare allegation, CPL-47215, was provided on 05/10/2021.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements
Section 9. Training

(e) All staff shall have Infant/Child Cardiopulmonary Resuscitation (CPR) and First Aid (FA) training and certification shall be kept current.

Explanation of Findings: During the facility inspection it was observed that staff member Deja has expired CPR/FA.

Action Required: CPR/FA must be completed and current at all times. Please have Deja renew her CPR/FA and send verification to the Licensing Office. Deja will need to be directly supervised by a qualified staff at all times until the time that the CPR/FA can be renewed. Also, please submit a corrective action plan to the Licensing Office showing how you will assure future staff CPR/FA will be renewed and kept current at all time to avoid future violations.

The Department requests your cooperation in ensuring compliance is met. In the absence of cooperation, the Department may take whatever steps are necessary to ensure the safety of children.


The Department's information may be shared with authorized individuals or agencies, which include, but are not limited to, the Attorney General, County Attorney, and law enforcement.

If you need a copy of the Rules, or assistance in requesting an Administrative hearing, you may contact the Department of Family Services Field Office in the county where you live.
