The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 08/26/2020, and investigated by Ashley Dame

A statement of childcare allegation, CPL-45967, was provided on 08/26/2020.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements

Section 16. Outdoor Play Space

- (i) Outdoor play equipment with a fall height of more than 24 inches shall be installed over a resilient surface covering the appropriate use zones:
- (i) Equipment with a fall height of more than 24 inches but less than seven (7) feet shall have six (6) inches of uncompressed resilient surface, except sand;

Explanation of Findings: Explanation of finding of non-compliance. At the 8/26/20 visit it was observed that the slides do not have six inches of surfacing.
