1. Finding: Non-Compliant

(e) All staff shall have Infant/Child Cardiopulmonary Resuscitation (CPR) and First Aid (FA) training and certification shall be kept current.

Explanation of Findings: During the facility inspection it was observed that there was no verification of CPR/FA on file for Coveney.

Action Required: Please submit verification of CPR/FA for Coveney to the Licensing Office as well as a corrective action plan showing how you will assure are records are completed and on file for all staff. Coveney must work in the facility with someone that is CPR/FA certified until the time hers has been completed.


**The Department's information may be shared with authorized individuals or agencies, which include, but are not limited to, the Attorney General, County Attorney, and law enforcement.**
