Explanation of Findings: It was observed at the time of the visit on 03/09/2021 that the physical file for Peggy and Jerry's staff records are missing Sex offender registry results, and DCI/FBI fingerprint results.

Action Required: Please submit a corrective action plan to child care licensing detailing what will be done to ensure that physical staff file will be complete, current, and up to date with all staff qualifications at all times. Future monitoring visits may occur.
