The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 08/19/2021, and investigated by Kristi Bennick

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

(ii) Be placed on a firm, flat surface for sleeping;

Explanation of Findings: A finding of non-compliance is based on licenser's observation of 3 infants sleeping in bouncers at the time of the visit.
