The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 11/16/2020, and investigated by Kristi Bennick

A statement of childcare allegation, CPL-46459, was provided on 11/16/2020.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements

Section 19. Infant and/or Toddler Care

(b) Sleeping infants shall:

(vi) Be placed in the same or adjacent room with enough light to see each infant's face, to view the color of the infant's skin and to check on the infant's breathing;

Explanation of Findings: A finding of non-compliance is based on licenser's observation at the visit on 11/16/2020. The infant/toddler room was too dark enough that licenser and staff could not see the color of the infant's face or the rise and fall of the infant's chest.

Action Required: Lamps or lights must be turned on to see the color of the infant's face and rise and fall of the chest. Please turn lights on immediately and send corrective action plan stating how you will maintain compliance.
