The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 10/12/2021, and investigated by Teddie Schrayner

A statement of childcare allegation, CPL-48033, was provided on 10/12/2021.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements
Section 3. Provider, Director, and Staff Requirement
(a) Before the provider, director, their staff, household member, substitute or volunteer assume responsibility for the direct care of children, work in the facility or move into the Family Child Care Home or Family Child Care Center, the following shall be on file:
(iii) A child abuse/neglect Central Registry check which does not reveal any disqualifying information.

Explanation of Findings: During the 10/12/2021 Facility Visit it was observed that there were two staff, Tami Clay and Melissa Sharberg (Falber) that did not have current central registry or sex offender results on file. Melissa was sent home and a substitute was placed in her room.

Action Required: Please submit a corrective action plan to the Licensing Office showing how you will assure that staff are qualified at all times prior to working at facility.

Administrative hearing procedures are included in the Wyoming Department of Family Services Contested Case Hearing Rules, Chapter 2, Substitute Care and Child Care Licensing and based on the above statute. If you need a copy of the Rules, or assistance in requesting an Administrative hearing, you may contact the Department of Family Services Field Office in the county where you live.
