The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 07/14/2022, and investigated by Veronica Endecott

A statement of childcare allegation, CPL-49357, was provided on 07/14/2022.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements
Section 19. Infant and/or Toddler Care.

(b) Sleeping infants shall:

(ii) Be placed on a firm, flat surface for sleeping with no loose bedding;

Explanation of Findings: Licenser observed an infant sleeping on the floor with its head on a pillow, blanket over the infant, and rotating slightly toward the infant's left side.

Action Required: The infant was removed from the pillow and placed correctly during the visit. Please complete a Corrective Action Plan ensuring that infants will be placed on their backs for sleeping.

(iii) Have nothing placed in or over the infant's sleep space;

Explanation of Findings: Licenser observed an infant sleeping in a crib with a blanket wrapped around them. Another infant was sleeping on the floor with a blanket over them

Action Required: The blanket was removed from the crib at the time of the visit.
Please complete a Corrective Action Plan ensuring that infants will have nothing placed
in the infant's sleeping space.

If you need a copy of the Rules, or assistance in requesting an Administrative hearing, you may contact the Department of Family Services Field Office in the county where you live.
