The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 05/14/2021, and investigated by Kristi Bennick

A statement of childcare allegation, CPL-47270, was provided on 05/14/2021.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

(c) Staff:child ratios and maximum group size shall be maintained as follows (Table 4-1) during all hours of operation when facilities care for only one (1) age group:

Explanation of Findings: At the time of the visit there were 16 kids sleeping in a room with 1 staff. There was not another staff in the building available to maintain ratio if children woke up. Three staff on break will be at the facility at 1:30 and facility will be in ratio.

Action Required: Facility must make a plan to be sure ratio is maintained in the building at all times, even at nap time.
