The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 08/19/2021, and investigated by Regien Hasperhoven

A statement of childcare allegation, CPL-47786, was provided on 08/20/2021.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements
Section 2. Capacity/Supervision Requirements

(b) Staff:child ratios and supervision requirements as described in this chapter shall be maintained at all times.

Explanation of Findings: Licensing supervisor RH arrive on the premise of the facility at 3:50 PM while owner Cathy Janish was by herself with 13 children ages 2 and up. Her staff had been called out on an emergency and came back shortly after RH arrived. Cathy stated she had called some parents to pick their children up. Five children were picked up by 4:30 PM so they were down to 8 children by that time, with 2 staff.
