Explanation of Findings: At the unannounced visit on 9/21/21 licenser observed a 7-month-old infant had a blanket in the crib with them.

Action Required: The blanket was removed at the time of the visit. Please fill out a Corrective Action Plan explaining how staff will be notified that nothing can be in the crib with an infant. The plan shall also include how future staff will be trained on how to sleep, infants.
