The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 12/22/2020, and investigated by Teddie Schrayner

A statement of childcare allegation, CPL-46591, was provided on 12/22/2020.

Explanation of Findings: During the 12/22/2020 facility visit it was observed that staff is leaving their classroom to go open the front door to let parents in which leaves the classroom unsupervised.

Action Required: Please move the sign in/sign out to an area where supervision can be maintained, or have a staff that is not working in staff/child ratios to be able to open the door. Please submit a corrective action plan to the Licensing Office.
