The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 06/03/2026, and investigated by Kathy Geringer.

A statement of childcare allegation, CPL-6127, was provided on 06/19/2026.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

Allegation: As per the director's report a child was left in care in the facility on 6/2/26, with no child enrollment records in place.

Explanation of Findings: Mrs. Fagenbush stated she planned on having the parent fill out enrollment records and return them to the facility the following day. The child was present in the facility from 10:27am to 3:53pm on May 26, 2026. He did not return for care after that day and is not currently enrolled in the facility. Child enrollment records must be on file prior to a child being cared for in the facility.

Action Required: Compliance completed by the child no longer being enrolled in the facility after 5/26/26. Please submit a Corrective Action Plan stating how you will ensure no children will receive care in the facility prior to all required enrollment records being on file.

Administrative hearing procedures are included in the Department of Family Services' **Wyoming Child Care Licensing Rules, Chapter 3, Section 5: Contested Case Hearing Rules**, and based upon the above statute.
