The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 03/06/2025, and investigated by Teddie Schrayner.

A statement of childcare allegation, CPL-5876, was provided on 03/06/2025.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements
Section 3. Owner, Director, and Staff Requirements.

(e) All staff, household members, substitutes, and volunteers shall complete child abuse/neglect Central Registry background checks and a National and state Sex Offender Registry check once a year, for Wyoming and each state the person has lived in the past five (5) years. These checks shall be kept current at all times, using the date the check was performed as the initial date, and repeated every year thereafter. An out-of-state abuse/neglect Central Registry background check for states lived in during the past five (5) years do not have to be repeated unless the person has lived in that state since the last check was performed. The Department may require a new child abuse/neglect Central Registry background check at any time for staff, household members, substitutes, and volunteers.

Allegation: It was discovered that Cristol was working without central registry which expired on 2/22/2025.

Explanation of Findings: Cristol was working while central registry and sex offender were expired. They were not renewed and expired on 2/22/2025.

Action Required: Variance request was received and Cristol will do the central registry online today. Please submit a corrective action plan to the licensing office showing how you will ensure that staff qualifications will remain current for all staff.

Administrative hearing procedures are included in the Department of Family Services' **Wyoming Child Care Licensing Rules, Chapter 3, Section 5: Contested Case Hearing Rules**, and based upon the above statute.
