The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 09/03/2025, and investigated by Teddie Schrayner.

A statement of childcare allegation, CPL-5997, was provided on 09/10/2025.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements
Section 12. Confidentiality.

(d) Children's names, pictures and any other information of them shall not be posted on social media sites without a parent or guardian's written permission.

Allegation: It was reported that on or about 08/29/25, a child's photograph was posted on the Wonderfully Made Facebook page without parental consent.

Explanation of Findings: Based on an interview with director and evidence received during the investigation, it has been found that on 08/29/2025 a staff member of the facility shared a photo of a child on the Wonderfully Made Facebook page. The facility did not have parental consent to share the child's photo on social media.

Action Required: Please submit a detailed corrective action plan to the Licensing Office showing how you will ensure that in the future everyone who takes photos of children or posts photos online is made aware of which children can and can not be photographed and which photos can and can not be shared on social media. I Update facility policies and consent forms for all children to ensure current information is on file for photographs/social media and include how you will ensure all staff have reviewed the updated policies and procedures. It is acknowledged by child care licensing that as soon as the Director became aware of the photo and lack of consent, the photo was immediately removed from the social media account.
