The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 01/14/2026, and investigated by Kathy Geringer.

A statement of childcare allegation, CPL-6048, was provided on 01/14/2026.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

**1. Finding: Non-Compliant**

Regulation: Chapter 7. Child Care Center  
Section 2. Capacity/Supervision Requirements.

(a) The facility, for 16 children or more, shall not be located in any person's residence. The licenser shall determine facility capacity based on individual room capacity for all rooms used by children. This room capacity shall be displayed in each room and never be exceeded. The licensed facility capacity shall never be exceeded.

Allegation: It has been found during an investigation and unannounced visits to the facility, that on multiple occasions in December 2025, the facility has been out of compliance with room capacity in the large room used for drop off and pick up.

Explanation of Findings: It has been found by Child Care Licensing during an investigation of the attendance records, that on multiple occasions in December 2025, the facility has been out of compliance with room capacity in the large room used for drop off and pick up, which has a room capacity of 16. This has been found to have occurred on December 12, 2025, when there were 19 children in this room and on December 15, 2025 when there were 18 children in this room.

Action Required: Room capacity shall not be exceeded at any time for any reason, including only 16 children at any time in the large room. Director, Assistant Director and ALL staff members shall complete and "Child Care Licensing and Capacity & Ratio" on Thinkific, and review Chapter 7, Section 2 of the WY Child Care Licensing Rules and shall sign a statement which includes their understanding each room's capacity in the facility and acknowledging that these numbers shall never be exceeded.
