The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 03/31/2025, and investigated by Kristi Bennick.

A statement of childcare allegation, CPL-5898, was provided on 04/09/2025.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements
Section 6. Discipline and Guidance.

(d) The following behavior shall be prohibited in all child care settings:

(ii) Rough handling of children, including but not limited to hitting, spanking, beating, shaking, pinching, pushing or other measures that could produce physical pain;

Allegation: It was reported that on or about 3/28/25, staff A.M. hit a child on the arm while providing care for the child.

Explanation of Findings: A finding of non-compliance is based on interviews and surveillance video of the area where the incident occurred.

Action Required: The facility took action, and A.M. is no longer employed at the facility. Please send a corrective action plan stating how you will maintain compliance in the future.

Administrative hearing procedures are included in the Department of Family Services' **Wyoming Child Care Licensing Rules, Chapter 3, Section 5: Contested Case Hearing Rules**, and based upon the above statute.
