The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 11/14/2023, and investigated by Ariel Schmitzer.

A statement of childcare allegation, CPL-5568, was provided on 11/16/2023.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 8. Food Safety, Health and Sanitation  
Section 6. Health Requirements for all Child Care Facilities.

(a) Communicable diseases

(iv) Exclusion of children:

(F) When communicable diseases occur and attendees or other staff have been exposed, all staff members shall be advised and all parents or guardians of exposed children shall be immediately notified by the provider to observe for symptoms; the specific identity of the persons infected with a communicable disease shall not be revealed except to authorized health authorities.

Allegation: It has been reported that in the month of November 2023, one or more individuals whom tested positive for a communicable disease were in the facility and parents/guardians of children exposed to these individuals were not notified of the exposure.

Explanation of Findings: It has been found through interviews with the director and evidence gathered during the investigation, that the director was notified about a child and a staff member tested positive for COVID and the director did not notify families or the department of health about the possible exposure.

Action Required: Submit a corrective action plan detailing how you will inform the appropriate parties of possible exposure when a communicable disease is reported in the facility.
