The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 10/14/2025, and investigated by Ariel Schmitzer.

A statement of childcare allegation, CPL-6022, was provided on 10/22/2025.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements
Section 2. Capacity/Supervision Requirements.

(h) In order to be counted in the staff:child ratio, staff shall be attending to the children. Necessary cooking, cleaning, janitorial, or similar tasks performed by a staff person counted in the staff:child ratio may take no longer than a few minutes, shall be done in such a way that the children are within sight and sound of the staff person, and the staff person can quickly and easily leave the task to handle direct child caring duties.

Allegation: It has been reported that on one or more occasions in the month of October 2025 staff members R.V. and A.E. were recording videos together and not adequately supervising children in care.

Explanation of Findings: It has been found through evidence gathered and interviews with staff and the director that in October of 2025 that staff members R.V. and A.E. were filming a video on the playground of the facility and not adequately supervising children.

Action Required: Please submit a corrective action plan detailing how you will ensure that children on the playground are being adequately supervised at all times by staff.

Regulation: Chapter 4. General Requirements

Section 12. Confidentiality.

(d) Children's names, pictures and any other information of them shall not be posted on social media sites without a parent or guardian's written permission.

Allegation: It has been reported that on one or more times in the month of October 2025 staff member A.E. posted a video to social media containing children's faces in the background without written consent from the parents of these children.

Explanation of Findings: It has been found through evidence gathered and interviews with staff and the director that staff member A.E. took a video while at the facility with children visible in the background and posted the video to her social media site TikTok account.

Action Required: Immediately have the employee remove the video from social media. Please create a cellphone usage policy that contains a confidentiality clause for children and have all staff sign and understanding agreement of the policy. Please send proof of the policy and staff signatures to licensing by no later than November 13th 2025. Please submit a corrective action plan detailing how you will ensure that all staff understand and will follow the cellphone usage policy.

If you disagree with the Department's finding of non-compliance for a violation, you may request an Administrative hearing within (10) days of your receipt of this letter (W.S. 14-4-108). Administrative hearing procedures are included in the Department of Family Services' **Wyoming Child Care Licensing Rules, Chapter 3, Section 5: Contested Case Hearing Rules**, and based upon the above statute. If you have questions, or need a copy of the Rules, you may contact the Department of Family Services Field office in the county where you live.
