The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 01/06/2022, and investigated by Tresa King.

A statement of childcare allegation, CPL-5203, was provided on 01/12/2022.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements  
Section 6. Discipline and Guidance

(d) The following behavior shall be prohibited in all child care settings:

(ii) Rough handling of children, including but not limited to hitting, spanking, beating, shaking, pinching, pushing or other measures that could produce physical pain;

Allegation: It was reported that prohibited discipline was used by staff in the past few weeks.

Explanation of Findings: Finding of non-compliance. Statements obtained from director support a finding of non-compliance. It was confirmed that staff may have roughly handled children by hitting them on the back of the head and forcing them to sit down by pressuring the back of the child's knees with the staff's foot.

Action Required: Complete a Corrective Action Plan detailing how you ensure that all staff refrains from using any prohibited discipline.

(d) The following behavior shall be prohibited in all child care settings:

(iii) Inappropriate use of language, including but not limited to profanity, name-calling, derogatory or demeaning terminology or screaming related to disciplinary purposes;

Allegation: It was reported that in the last few weeks staff used derogatory terminology to describe children in care while child care children were present.

Explanation of Findings: Finding of non-compliance. Statements obtained from director support a finding of non-compliance. It was confirmed that staff used derogatory terminology to describe children when other children's were present.

Action Required: Complete a Corrective Action Plan detailing how you will ensure all staff does not use negative terminology when talking about the children under any circumstances when child care children are present.

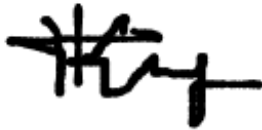
**The Department's information may be shared with the authorized individuals or agencies, which include, but are not limited to, the Attorney General, County Attorney, and law enforcement.**
