The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 09/10/2019, and investigated by Regien Hasperhoven.

A statement of childcare allegation, CPL-4814, was provided on 09/24/2019.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

## 1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements Section 3. Provider, Director, and Staff Requirement (e) All staff, household members, substitutes, and volunteers shall complete a child abuse/neglect Central Registry background check once a year and a full fingerprint based national criminal history record background check every five (5) years.

Allegation: On 9/10/2019 it came to licenser Kathy Geringer's attention that the Central Registry checks for Mary Aragon, AJ McDaniel and Jennifer Mumaugh were expired. The previous check had been done on 8/16/2018 and expired on 8/16/2019. The new requests were not sent in to the Central Registry division until 8/29/2019. They should have been sent in in time to be processed and returned by 8/16/2019.
