The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 09/14/2020, and investigated by Michelle Tucker

A statement of childcare allegation, CPL-46043, was provided on 09/14/2020.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

## 1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements

Section 3. Provider, Director, and Staff Requirement

- (a) Before the provider, director, their staff, household member, substitute or volunteer assume responsibility for the direct care of children, work in the facility or move into the Family Child Care Home or Family Child Care Center, the following shall be on file:
- (iii) A child abuse/neglect Central Registry check which does not reveal any disqualifying information.

Explanation of Findings: It was found at an unannounced visit on September 14, 2020, employee Brenda Madrid's central registry expired in February of 2020 and was not rerun prior to returning to work at the facility in June 2020.

Action Required: Complete a central registry form and a variance request for Brenda Madrid. Complete a corrective action plan detailing how the facility with maintain compliance with staff record requirements.
