The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 12/04/2019, and investigated by Amanda Jarrett

A statement of childcare allegation, CPL-44761, was provided on 12/04/2019.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements

Section 16. Outdoor Play Space

(a) There shall be a minimum of 75 square feet of outdoor play space for each child when ages of children are combined, except as provided in Section 15.

Explanation of Findings: Facility has a Variance in place for Outdoor Play Space. The indoor area approved for play space is full of Christmas trees. Facility is not compliant with terms of Variance in place.

Action Required: Set up play space to ensure daily use for children in care.

Action Met Comments: 12/06/2019- Play space has been set up inside of the worship center and pictures have been received by licensing of the space. The space is now usable.

Administrative hearing procedures are included in the Wyoming Department of Family Services Contested Case Hearing Rules, Chapter 2, Substitute Care and Child Care Licensing and based on the above statute. If you need a copy of the Rules, or assistance in requesting an Administrative hearing, you may contact the Department of Family Services Field Office in the county where you live.
