The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 10/11/2021, and investigated by Kelli Dunne.

A statement of childcare allegation, CPL-5160, was provided on 10/11/2021.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements Section 3. Provider, Director, and Staff Requirement

(e) All staff, household members, substitutes, and volunteers shall complete a child abuse/neglect Central Registry background check once a year and a full fingerprint based national criminal history record background check every five (5) years.

Allegation: It was found by Licenser KD that the Director and one or more staff members allowed their annual child abuse/neglect Central Registries to expire and did not renew them in a timely manner. Additionally, the Director and staff members were working on the morning on October 11th without current registries on file.

Action Required: The annual child abuse/neglect central registries for Director and (4) staff were sent by Licenser KD in the correct format to Licensing Supervisor on 10.11.21 for expedite and were completed on the same day. A corrective action plan needs to be completed detailing how this will not happen again.
