The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 05/20/2020, and investigated by Joshua Seilaff.

A statement of childcare allegation, CPL-4948, was provided on 05/20/2020.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements

Section 3. Provider, Director, and Staff Requirement

(e) All staff, household members, substitutes, and volunteers shall complete a child abuse/neglect Central Registry background check once a year and a full fingerprint based national criminal history record background check every five (5) years.

Allegation: Reporter alleges that on or about May 20, 2020, the director was providing direct care for children without having current central registry on file for herself and for a household member.

Explanation of Findings: A finding of non-compliance is issued based on the evidence presented by child care licensing from the most recent staff summary, and from the phone call conversation with the provider which confirmed that central registry was expired as of on 05/06/2020.

Action Required: Please submit a completed corrective action plan to child care licensing no later than June 4, 2020, detailing how you will assure that staff and household qualifications, including Central Registry will be kept current in the future. Additional visits may occur to monitor compliance.
