The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 08/15/2022, and investigated by Teddie Schrayer.

A statement of childcare allegation, CPL-5335, was provided on 08/17/2022.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements Section 14. Health and Safety Requirements.

(d) All rooms used by children shall be adequately heated, cooled, illuminated, and ventilated.

Allegation: The reporter alleges that the daycare is around 80 degrees, it is hot, and the children are leaving drenched in sweat.

Explanation of Findings: Based on interviews, information, and Licenser's observations during the investigation there is a finding of non-compliance. The facility had been operating during the time of electrical repairs and it was determined that the vent on the building's swamp cooler was inadvertently left closed resulting in a loss of air circulation, making it feel hot and humid in the child care area. The temperature was varying from 78-85.7 degrees in the building when Licensing was present. Based on Caring For Our Children standards the facility should be maintained at a draft-free temperature of 74 degrees to 82 degrees at thirty to fifty percent relative humidity during the summer months.

Action Required: Upon notification of the allegations, the child care owner and building owner began addressing the concern and discovered that the swamp cooler vent was inadvertently closed. They immediately turned the venting switch back on and provided further solutions to the cooling issue to ensure the facility could be maintained between the CFOC standard temperatures at all times when children are present during the summer months. The facility immediately submitted corrective actions taken, as well as future plans to address the issue. No additional compliance is

needed at this time. Additional monitoring visits may be conducted to assure correct temperatures are being maintained.
