The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 11/16/2021, and investigated by Kelli Dunne.

A statement of childcare allegation, CPL-5183, was provided on 12/01/2021.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements Section 2. Capacity/Supervision Requirements (m) There shall be at least one (1) adult staff supervising the care of children at all times.

Allegation: It was self reported that on 11.16.21 a child was in the classroom without adult staff supervision.

Explanation of Findings: Finding of non-compliant based on self report, and statements obtained from staff interviewed during the investigation. It was confirmed that on 11/16/2021, a child was left in the room unattended for a short period of time before other staff in the building found the child in the hall outside the classroom and re-united the child with group and classroom staff on the playground.

Action Required: A Corrective Action Plan needs to be developed outlining how this will not happen in the future.

Administrative hearing procedures are included in the Department of Family Services' **Wyoming Child Care Licensing Rules, Chapter 3, Section 5: Contested Case Hearing Rules**, and based upon the above statute.
