The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 08/29/2019, and investigated by Kathy Geringer

A statement of childcare allegation, CPL-44339, was provided on 09/25/2019.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements

Section 16. Outdoor Play Space

(e) The outdoor play area shall be enclosed with a fence. The fence shall be at least four (4) feet in height and the bottom edge shall be no more than three and one-half (3 1/2) inches off the ground.

Explanation of Findings: Part of the play yard fence has been taken down to allow for some construction work, the fence had been down for more than a week.

Action Required: Please submit a Corrective Action Plan, stating in the future what actions will be taken to ensure the children still have an enclosed play yard, if necessary work in your play yard requires the fence to be removed.
