The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 12/12/2018, and investigated by Pamela Konstant

A statement of childcare allegation, CPL-42848, was provided on 12/12/2018.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements
Section 14. Health and Safety Requirements

(b) Rooms not designated and approved for child care shall be made inaccessible to children with the exception of rooms used as an evacuation route or shelter.

Explanation of Findings: During an investigative visit of December 12, 2018, Licenser Pamela Konstant observed that the door to the kitchen, while closed, was unlocked and not made inaccessible to children by means of child proof knobs.

Action Required: Place a child proof knob cover on the knobs for this door.

Action Met Comments: Gate is being used for kitchen as door does not secure correctly. PDK

2. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements
Section 14. Health and Safety Requirements

(I) Potentially dangerous or unsafe items shall be made inaccessible to children.

Explanation of Findings: During an investigative visit of December 12, 2018, Licenser Pamela Konstant observed numerous chemical products and sharp knives in kitchen cabinets and drawers within reach of children with no child proof locks. The kitchen

door was also not locked or made inaccessible, allowing for the potential for direct access to the dangerous items.

Administrative hearing procedures are included in the Wyoming Department of Family Services Contested Case Hearing Rules, Chapter 2, Substitute Care and Child Care Licensing and based on the above statute. If you need a copy of the Rules, or assistance in requesting an Administrative hearing, you may contact the Department of Family Services Field Office in the county where you live.
