The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on: 01/23/2019, and investigated by Pamela Konstant

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

Reported Allegation:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements
Section 3. Provider, Director, and Staff Requirement
(e) All staff, household members, substitutes, and volunteers shall complete a child abuse/neglect Central Registry background check once a year and a full fingerprint based national criminal history record background check every five (5) years.

Reason: On January 23, 2019, during a review of staff background checks for a Variance Request, Licenser Pamela Konstant observed that individuals at the facility had expired Central Registries and were working with children.

Explanation of Findings: During a review of the licensing records, Licenser Pamela Konstant found that an employee was actively working at the facility while their Central Registry had expired.

Compliance Action Required: All staff must have a current Central Registry to be working in the facility. Staff without a cleared Central Registry will not be permitted to work until their Central Registry clearance comes back. Facility will develop a plan to ensure that all Central Registry clearances are done annually as required and that no one continues to work with expired Central Registry reports.
