(e) All staff, household members, substitutes, and volunteers shall complete a child abuse/neglect Central Registry background check once a year and a full fingerprint based national criminal history record background check every five (5) years.

Explanation of Findings: It was discovered at visit that one staff member is working with an expired WY central registry. It has been expired for a period of one week.

Action Required: Staff member was sent home during visit and may not work until staff requirements have been completed and returned or an approved variance request has been submitted and approved. (2) children were taken downstairs so that the staff/child ratio remained compliant after staff member left facility. A WY central registry form was provided by Licenser and completed by staff member at visit. Licenser will email form to central registry on behalf of staff member. A Corrective Action Plan needs to be completed detailing how this will not happen again in the future.
