The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 06/10/2021, and investigated by Kelli Dunne.

A statement of childcare allegation, CPL-5115, was provided on 06/18/2021.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

## 1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements

Section 9. Training

(b) Within three (3) months of staff's start date and prior to assuming responsibility for unsupervised direct care of children, all staff shall receive the approved pre-service and facility staff orientation training.

Allegation: During the investigation visit it was discovered that in the last 6 weeks, a staff member was caring for daycare children without being supervised by a qualified staff and without completing pre service training.

Explanation of Findings: During the investigation visit it was discovered that in the last 6 weeks, a staff member was caring for daycare children without being supervised by a qualified staff and without completing pre service training. Wyoming Childcare licensing rules require that pre service be completed before working unsupervised or providing direct care to children.

Action Required: Staff members are not permitted to assume responsibility for unsupervised direct care of children without the required training being completed. A Corrective Action Plan detailing how this will not happen again needs to be completed and sent to Licenser by 6.30.21 Corrective Action Plan received on 6.23.21. Compliance Monitoring Visit completed on 7.9.2021.

Administrative hearing procedures are included in the Department of Family Services' **Wyoming Child Care Licensing Rules, Chapter 3, Section 5: Contested Case Hearing Rules**, and based upon the above statute.
