The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 12/23/2020, and investigated by Kelli Dunne.

A statement of childcare allegation, CPL-5032, was provided on 01/05/2021.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Compliant

(I) Potentially dangerous or unsafe items shall be made inaccessible to children.

Allegation: On 12.23.20 a report was received that on 12.14.20 a marijuana vape pen was found in the facility in an area that could be reached by children.

Explanation of Findings: During this investigation and through interviews conducted, there was no evidence found that in the last 4 months a potentially dangerous or unsafe item was accessible to children.

Section 14. Health and Safety Requirements

(t) Staff and household members shall not be under the influence or consume alcohol, illegal drugs or misuse prescription drugs or over-the-counter drugs, on or off the premises during operating hours and while transporting children. The use of tobacco, tobacco products or electronic cigarettes is prohibited in the facility when children are present.

Allegation: On 12.23.20 a report was received that on 12.14.20 it was suspected that a staff member consumed and was under the influence of marijuana during operating hours.

Explanation of Findings: During this investigation and through interviews conducted, there was no evidence found that in the last 4 months a staff member consumed and was under the influence of illegal drugs during operating hours.
