The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 07/01/2020, and investigated by Tresa King

A statement of childcare allegation, CPL-45688, was provided on 07/01/2020.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements Section 19. Infant and/or Toddler Care (b) Sleeping infants shall: (iii) Have nothing placed in or over the crib, bassinet, or play pen;

Explanation of Findings: It was observed during facility visit on 7/1/202 infant was sleeping a pack and play, boppy pillow and blanket was hanging over the side of the crib. Child was 6 months old.

Action Required: Immediate correction was completed. Boppy pillow and blanket removed. CAP required, pending.

2. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements Section 19. Infant and/or Toddler Care (b) Sleeping infants shall: (viii) Not be swaddled without a licensed health care professional statement, including instructions and a time frame for swaddling an infant, on file. Swaddling is prohibited for infants that have the ability to roll over independently. A one-piece sleeper or sack equipped with an attached system that fastens securely only across the upper torso may be used; however shall not restrict the arms, hips, or legs of the infant. The sleeper or sack shall be used to manufacturer's guidelines and shall not slide up around the infant's face; and

Explanation of Findings: It was observed by licenser during facility visit 7/1/2020, infant was sleeping in a pack and play and was swaddled with a light blanket. Child is 6 months old.

Action Required: Immediate correction was done, child was unswaddled. CAP is required, form left with diretor.

Administrative hearing procedures are included in the Wyoming Department of Family Services Contested Case Hearing Rules, Chapter 2, Substitute Care and Child Care Licensing and based on the above statute.
