The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 08/01/2019, and investigated by Kathy Geringer

A statement of childcare allegation, CPL-44156, was provided on 08/21/2019.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements
Section 19. Infant and/or Toddler Care

(b) Sleeping infants shall:

(ii) Be placed on a firm, flat surface for sleeping;

Explanation of Findings: During the facility visit of 8/1/19, at 1:56pm the Licenser observed two infants sleeping in swings. Ms. Mladenik was in the back yard at the time, the children were supervised inside by staff A.V. The infants should have been moved from the swings as soon as possible after falling asleep.

Action Required: Please submit a Corrective Action Plan to the Licensing Office by 8/28/19, that explains what procedures will be implemented to ensure infants will not sleep in swings, and if an infant falls asleep in a swing he/she will be moved as soon as possible.

(d) Food Service for Infants:

(iii) Bottle propping shall not be permitted. Infants shall receive individual direct care

during feeding. Bottles shall not be left with a sleeping infant.

Explanation of Findings: During the facility visit of 8/1/19, the Licensor observed an infant sleeping in a swing with a bottle on his chest. As per Licensing rules, Infants shall received individual direct care during feeding, and bottles shall not be left with a sleeping infant.

Action Required: Please submit a corrective action plan to the Licensor by 8/28/19 that explains what corrections will be made during and after bottle feeding to prevent this situation from occurring again.
