The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 10/29/2020, and investigated by Kelli Dunne

A statement of childcare allegation, CPL-46362, was provided on 10/29/2020.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements Section 3. Provider, Director, and Staff Requirement (e) All staff, household members, substitutes, and volunteers shall complete a child abuse/neglect Central Registry background check once a year and a full fingerprint based national criminal history record background check every five (5) years.

Explanation of Findings: It was discovered by Licenser KD during an unannounced visit that (1) staff member is currently working with an expired central registry and sex offender check for a period of (8) weeks.

Action Required: Licenser KD spoke to Director at the time of the visit regarding the staff member's ineligibility to work until staff requirements have been met. Licenser will send Director a variance that can be submitted and if approved, staff member may work under supervision until requirements have been completed and returned. A corrective action plan needs to be completed detailing how this will not happen again.

If you disagree with the Department's finding of a non-compliance violation, you may request an Administrative hearing within (10) days of your receipt of this letter (W.S. 14–4–108). Administrative hearing procedures are included in the Wyoming Department of Family Services Contested Case Hearing Rules, Chapter 2, Substitute Care and Child Care Licensing and based on the above statute. If you need a copy of the Rules, or assistance in requesting an Administrative hearing, you may contact the Department of Family Services Field Office in the county where you live.
