The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 09/20/2021, and investigated by Kelli Dunne.

A statement of childcare allegation, CPL-5153, was provided on 09/21/2021.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements Section 3. Provider, Director, and Staff Requirement

- (a) Before the provider, director, their staff, household member, substitute or volunteer assume responsibility for the direct care of children, work in the facility or move into the Family Child Care Home or Family Child Care Center, the following shall be on file:
- (iv) Completed National Sex Offender Registry check and state Sex Offender Registry checks for Wyoming and for each state the person has lived in for the past five (5) years for staff, household members, substitutes, and volunteers. A person shall not be employed or present in the facility if the Sex Offender Registry check(s) states the person is a registered sex offender.

Allegation: It was discovered on 9.20.21 by Licenser KD that (1) one staff person has been working with an expired out of state background check. The background has been expired for a period of 18 days.

Action Required: Licenser KD spoke to Director regarding the staff member's ineligibility to work until staff requirements have been met or an approved variance request has been obtained. A corrective action plan needs to be completed detailing how this will not happen again.
