The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 09/10/2020, and investigated by Kristi Bennick

A statement of childcare allegation, CPL-46034, was provided on 09/10/2020.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements

Section 3. Provider, Director, and Staff Requirement

(a) Before the provider, director, their staff, household member, substitute or volunteer assume responsibility for the direct care of children, work in the facility or move into the Family Child Care Home or Family Child Care Center, the following shall be on file:

(iii) A child abuse/neglect Central Registry check which does not reveal any disqualifying information.

Explanation of Findings: At the time of visit on 9/10/2020, Clara and Sheila did not have central registry checks completed and on file at the facility.

Action Required: Clara and Sheila were sent home and 5 children were sent home to maintain ratio with the available qualified staff at the facility. Clara and Sheila may not return to the facility until they are fully qualified staff, including central registry results with no disqualifying information. Clara and Sheila will also need first aid/cpr, facility orientation, and health and safety pre-service training to be left alone with children. Those items must also be completed withing 90 days.
